1) Reports by Prax LOR

There was a hydrogen leak which is why the alarm sounded

1st March shutdown – much smaller than last year with it being a quarter of the size of last year. 45 – 60 day turnaround. The hedge has been cut.

2) Reports by Ward Councillors

Air Fryers – over 80s should have them. Under 80s need to collect from Baysgarth Leisure. Letters / emails will be sent. In Bloom grants – the PC can apply during the last part of March / April

A180 and A15 bins are removed from the lay-bys and NLC believe this has seen an improvement in litter; some Councillors and the Clerk felt this was not the case on the A160 / A180.
